INVITATION OF BIDS FROM MANUFACTURERS/ SUPPLIERS/ IMPORTERS/ CONTRACTORS FOR THE SUPPLY OF MEDICAL ITEMS TO SRI LANKA NAVY FROM 01ST JANUARY TO 31ST DECEMBER IN THE YEAR 2025 ON RATE CONTRACT BASIS

- 1. The Chairman, Department Procurement Committee of the Sri Lanka Navy (SLN), invites bids from Manufacturers, Suppliers, Importers and Contractors to supply one or more of the following separated tenders of Medical Items to Sri Lanka Navy for the period from 01st January 2025 to 31st December 2025 on rate contract basis. The validity of the submitted rate of the bids should be from 01st January 2025 to 31st December 2025. Details of this tender invitation are available in Sri Lanka Navy website www.navy.lk.
 - (a). Selected contractors should transport all the items ordered by SLN to Central Medical Stores at Naval Headquarters, P.O Box 593, Colombo 01.
 - (b). The suppliers who are interested should submit their bidding forms obtainable from the Staff Officer (Medical Supplies),Sri Lanka Navy, Naval Headquarters, Colombo 01 during working days between 1000 hrs to 1400 hrs from **02**nd **September 2024 to 22**nd **September 2024** on payment of a non-refundable application fee of **Rs. 5,000.00** in cash for each category of medical Items to the Director Finance, Naval Headquarters, P.O. Box 593 Colombo 01.
- 2. The detailed information of Medical Items and approximate quantities required for the 01st January 2025 to 31st December 2025 for each tender will be issued with the bidding forms.

- 3. The bidders shall possess with following requirements to be eligible for submission of bids. (Will be considered under the process of the evaluation of bids)
 - a. Two years experience in supplying of Medical Items to public/private organizations in similar capacity with satisfactory performance records.
 - b. Copy of Valid NMRA Certificate. (Must be a valid certificate)
 - c. Sound financial capability.
 - d. Bid Bond(Valid up to 06 months from tender opening date)
 - e. Satisfactory Tax payment records.
 - f. Adequate communication facilities. (Telephone/s, Mobile Phone/s, Fax/es, E- mail)
 - g. Adequate storage facilities. (Warehouses)
 - h. Adequate Staff, Personnel and Office facilities.
 - i. Adequate transport facilities.
 - j. Copy of Business Registration or Incorporation Certificate with an operational record of last three years.
- 4. The declaration of VAT registration number along with the bidding document is a mandatory requirement. The bidders who are exempted from VAT should produce a letter from the Commissioner General of Inland Revenue Department certifying that the company has been exempted for VAT. Any bid which does not fulfill above requirements shall be rejected.
- 5. The bids duly signed by the applicant should be submitted after placing the official seal there under as a compulsory requirement. The envelop containing the tender should be marked "BID FOR THE SUPPLY OF (<u>Category of Items</u>) FOR THE YEAR 2025, Category No (SLN/CMS/...../RC/2025) and date/ time of opening of bids" on top left hand corner and should be posted to the following address under registered post or to be deposited in the tender box at Naval Headquarters;

- 7. The bidding documents which are incomplete and not accompanied with required documentary evidence shall be rejected. The Chairman, Department Procurement Committee reserves the right to accept or reject any bid application.
- 8. Selected bidders will be notified by registered post for signing of agreement.
- 9. The bidding forms can be inspected free of charge at the office of the Staff Officer (Medical Supplies), Sri Lanka Navy, Naval Headquarters, Colombo 01.
