1. TECHNICAL SPECIFICATIONS

AMMONIUM NITRATE

2 REQUIREMENTS

2.1.1 The material shall be in the form of prills, lumps or crystals, as agreed to between the purchaser and the supplier, and white in colour. It shall be free from grit, foreign matter and visible impurities.

2.1.2 Ninety five (95) per cent of the material shall be between the size from 2.36 mm to 1.00 mm.

2.1.3 Where anti-caking agents are added they shall be compatible with the explosives and shall not cause undue frothing in the manufacturing process. The quantity and nature of the agent shall be declared by the supplier.

2.1.4 The material shall comply with the requirements specified in Table 1, when tested according to the methods prescribed in Column 4 of Table 1.

3 PACKAGING

The material shall be packaged in polyethylene lined bags as agreed to between the purchaser and the supplier. The polyethylene sheet shall not be less than 0.05 mm thickness.

Each bag should be weight 25 kgs

4 MARKING AND/ OR LABELING

Each package shall be legibly and indelibly marked or labelled with the following information:

- Name and grade of the material;
- Mass of the material in the package;
- Manufacturers' name or trade-mark, if any;
- Year of manufacture;
- Batch Number;
- Shelf life / best before; and
- Pictograms/warnings/statements as per the GHS classification and labeling of chemicals.
